

COMPETITION RULES

“STOLLAR - SALE'S MASTER ” 2023

§ 1 Promoter

The competition under the name "**STOLLAR - SALE'S MASTER**" , hereinafter referred to as the Promotion, is run by STOLLAR Systemy Okienne Godlewska Spółka Jawna, with its registered office at ul. Północna 50A, 16-400 in Suwałki, entered into the National Court Register with the KRS number: 0000373250, with the tax identification number NIP: 844-233-87-92, hereinafter referred to as the Competition Organizer .

§ 2 Definitions

- 1 **The regulations** are these promotion regulations.
- 2 **The promotion is a Contest** called "**STOLLAR - SALE'S MASTER**" , which is conducted and supervised by the Organizer.
- 3 **A partner** is any entity cooperating under the Promotion in question with STOLLAR Systemy Okienne Godlewska Spółka Jawna, operating in the form of /commercial law company, sole proprietorship, civil law partnership/, having signed a current cooperation agreement
- 4 **A participant** is an entity that meets all of the following criteria:
 - during the Promotion, he/she will correctly apply for participation in the Promotion on the terms set out in these Regulations;
 - is a partner of the Organizer
 - is not an employee of the Organizer;
 - is not a family member (i.e. ascendant, descendant or spouse) of an employee of the Organizer;
 - has an address for delivery within the territory of the European Union, where it receives courier mail;
- 6 **Duration of the Promotion** - the period specified in §4 during which the Promotion is conducted;
- 7 **Points** - collected points with the value expressed in PLN specified in the regulations
- 8 **Order** - ZLE-23-... order confirmed for execution, for which the Participant made a 45% advance payment or paid 100% of its value on the order date;
- 9 **Guardian** - a person authorized by the Organizer to handle the Promotion in question
- 10 **Prize** - material prizes listed in § 5 of the Regulations

§ 3 General provisions

- 1 The Regulations specify the conditions for participation and running the Promotion, the prizes provided for in the Promotion and the rules for their receipt, as well as the complaint procedure.
- 2 Each Participant taking part in the Promotion is obliged to read the Regulations and its provisions become binding for the Organizer and the Participant at the time of the Participant's application for the Promotion.
- 3 The promotion is organized to promote the purchase of PVC joinery in the system

1 variant :

STOLLAR Liv Line + triple glazing with a warm frame

2 variant :

STOLLAR Energo 82 + triple glazing with a warm frame

3 variant :

STOLLAR Linear Q4 Line + triple glazing with a warm frame

4 variant :

STOLLAR SMOOVIO / HST + triple glazing with a warm frame

- 4 The promotion is carried out only in the territory of the European Union.

§ 4 Terms and conditions of participation in the Promotion




- 1 The Promotion lasts from 01/06/2023 to 20/12/2023 and this is the last day on which the Participant of the Promotion, having met all the conditions, may obtain the right to receive the Prize;
- 2 The notification may be made by a partner, as well as an authorized employee within the time limit specified in point 1
- 3 In order to apply for participation in the Promotion, it is necessary to accept the regulations within the time limit specified in § 4, point 1 and supplement it with the data indicated in § 9, and then send a scan of the supplemented and accepted regulations by e-mail entitled: "APPLICATION - STOLLAR SALE'S **MASTER 2023**" to the e-mail address konkurs@stollar.pl and deliver a copy of the so accepted and supplemented regulations to the Supervisor on behalf of Stollar or by sending the original of the above in paper form to the address of the company's registered office indicated in § 1
- 4 During the promotion, the Participant should purchase window joinery in the system /systems indicated in § 3 point 3
- 5 If the conditions of the Promotion are met, the Participant will be assigned points to each order placed from the date of submission, with the following:

- a) **100 EURO** net spent on the purchase of joinery in **STOLLAR Liv Line** with 3 pane package equals **1,25 POINT** being the equivalent of **5 PLN**.
 - b) **100 EURO** net spent on the purchase of joinery in **STOLLAR ENERGO 82** with 3 pane package equals **1 POINT** being the equivalent of **4 PLN**.
 - c) **100 EURO** net spent on the purchase of joinery in **STOLLAR LINEAR Q4 LINE** with 3 pane package equals **0,75 POINT** being the equivalent of **3 PLN**.
 - d) **100 EURO** net spent on the purchase of joinery in **STOLLAR SMOOVIO / HST** with 3 pane package equals **2 POINT** being the equivalent of **8 PLN**.
- 6 POINTS will be awarded to the participant for all Orders made in accordance with these regulations in accordance with the variants **indicated in § 3 point 3** ;
- 7 One ZLE-23-... order confirmed for execution may be assigned to only one participant of the promotion;

§ 5 Prizes and their receipt

- 1 Prizes awarded in the Promotion depend on the number of points collected, with the value of the award in Polish zloty not exceeding the equivalent value of the points expressed in PLN , which is illustrated in the example below:

- 2 Material prizes in the organized promotion will be all products available on the website of the mediaekspert.pl commercial network, available on the day of placing the order by the Organizer;
- 3 Not later than on the 21st working day after the end of the Promotion, the Organizer will inform the participant about the number of points collected by him and their equivalent in PLN.
- 4 The Participant is obliged to indicate to the Organizer the prize of his choice in the mediaexpert.pl commercial network, where it is available, no later than 7 days from the date of informing him about the number and value of the collected points; the participant should inform the Organizer about the above by sending an appropriate e-mail to the address konkurs@stollar.pl

- 5 The value of the prize will be accepted on the day it is indicated by the Participant, but not later than on the day of placing the order for the prize by the Organizer;
- 6 In the event of discrepancies between the number of points determined and awarded by the Organizer and the number of points that should actually be awarded, the participant is obliged to report this fact to the Organizer by sending a relevant message to the e-mail address konkurs@stollar.pl within a period not exceeding 3 days from the date of receipt of the message from the organizer about the number of points awarded; failure to meet the indicated deadline for reasons attributable to the participant is tantamount to losing the right to submit a complaint;
- 7 Prizes will be shipped within 60 business days of the end of the promotion. Prizes will be delivered via courier service selected by the Organizer to the address indicated by the Participant in the application for participation in the Promotion. The Participant does not bear the costs of delivery of prizes;
- 8 The Promotion Participant is entitled to min. 1 prize (min. 1 item)
- 9 In the case of choosing a prize of a lower value than the value of collected points - the remaining points are forfeited without the possibility of their exchange;
- 10 In the case of choosing a prize with a higher value than the value of the accumulated points - the participant is obliged to pay the difference resulting from the value of the prize and the value of the accumulated points.
- 11 The Participant is not entitled to transfer the right to the prize to a third party;
- 12 The organizer allows the participant to exchange the accumulated points for a discount on the order/orders in the full amount of the collected points. The included discount will be settled by the organizer. The discount may be included in several orders, if its value exceeds 10% of the value of the order, including the granted partner discount.
- 13 Accumulated points cannot be exchanged for cash. The Participant has no right to demand payment of any amount of cash equivalent instead of the prize. The Participant has no right to request the Organizer to exchange the received prize for another copy;
- 14 Pursuant to the provisions of the Personal Income Tax Act, prize winners are subject to taxation under general rules. Flat-rate income tax is not deducted from the prize if its one-time value does not exceed PLN 2,000.00 gross. This exemption does not apply to a taxpayer who has received an award in connection with his business activity. Then the reward is the income from this activity. In accordance with the regulations of the Promotion under which the Participant received the prize, the tax on the prize is covered by the Participant of the Promotion;

§ 6 Complaint/guarantee procedure rules

- 1 The Organizer is obliged to deliver prizes free from defects, however, if the delivered prize has a defect, the Organizer is not responsible to the Participant for its occurrence;
- 2 The Organizer is not responsible for defects of the prize, either under the warranty or under the guarantee. All claims should be addressed directly to the manufacturer or commercial network;
- 3 The complaint/warranty procedure is carried out in accordance with the rules indicated in the guarantee card for the prize (of the ordered product) and applicable law, in particular the Act of 23 April 1964. Civil Code

- 4 Complaints / warranty claims should be submitted by e-mail to the address indicated in the warranty card of the prize product or in person at a stationary service / sales point
- 5 After receiving the prize, it is recommended to check (if possible) whether the parcel has no signs of damage and whether it is consistent with the application (if possible). If the Participant finds the parcel damaged at the time of its delivery, it is recommended, in order to speed up the complaint / warranty procedure, to immediately draw up a written report in the presence of the courier delivering the parcel and refuse to collect the prize;

§ 7 Personal data protection

- 1 The personal data of the Promotion Participants will be processed in accordance with the provisions of the Act of August 29, 1997. on the protection of personal data and the Act of July 18, 2002. on the provision of electronic services as well as Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC, for the purpose of carrying out the Promotion, as well as for the delivery and realization of prizes, as well as for the purpose of publishing the list of awarded Participants;
- 2 The administrator of personal data within the meaning of the Act of August 29, 1997 on the protection of personal data processed as part of this promotion is the Organizer;
- 3 Participants have the right to inspect their personal data and correct them. This right may be exercised by sending an appropriate request in writing to the Organiser's address;
- 4 Personal data provided in the application form are treated as confidential and are not visible to unauthorized persons;
- 5 Participants in the Promotion have the right to access data, rectify, delete or limit processing. This right may be exercised by sending an appropriate request in writing to the Organiser's address;
- 6 Providing personal data by the Participant is voluntary, although necessary to participate in the Promotion;
- 7 The Organizer is not responsible for providing an incorrect address by the participant of the Promotion, or other data that makes it impossible to identify him;
- 8 The Organizer does not disclose personal data to entities other than those authorized under the applicable law;
- 9 Personal data is processed only by persons authorized by the Organizer;
- 10 The participant has the right to object to further processing, and in the event of consent to the processing of data, to withdraw it. The exercise of the right to withdraw consent does not affect the processing that took place until the consent was withdrawn;
- 11 The participant has the right to lodge a complaint with the supervisory authority;
- 12 After the end of the Promotion, but not later than within 90 days from its end, all data of participants who took part in the Promotion will be anonymized ;
- 13 The participant of the promotion may at any time delete his data from the administrator's database;

§ 8 Final Provisions

- 1 The Regulations are available at the Organiser's headquarters, at the Regional Managers and at STOLLAR's BOK;

- 2 The Regulations are not subject to the provisions of the Act of November 19, 2009 on gambling games.
- 3 These Regulations are subject to Polish law and all its provisions should be interpreted in accordance with this law. If it is found that any provision of these Regulations is contrary to the provisions of generally applicable law, the relevant provisions shall apply, which does not affect the validity of the remaining provisions of the Regulations;
- 4 The final interpretation of the regulations of the promotion belongs solely to STOLLAR Systemy Okienne Godlewska Spółka Jawna;
- 5 During the Promotion, the Organizer reserves the right to modify the rules and its duration without giving any reason. Information about the above will be made available in the manner indicated in point 1.

Example of calculating points and their values for Variant 1:

The participant submits an application for participation in the competition on June 1, 2023, during the promotion period he will make purchases in accordance with Variant 1 specified in § 3 point 3 for the amount

PLN 40 000.00 net, in return he will receive according to the calculations in the example § 4 point 5

450 POINTS equivalent to PLN 1800 zł

An example of the implementation and course of the promotion:

During the period covered by the promotion, the Participant registers in the competition and purchases window joinery in accordance with Variant 1 described in § 3 point 2 for the total amount of PLN 40,000 net. In return for the purchase, he receives 450 Promotional Points, which is equivalent to PLN 1800 zł gross (each Promotional Point is worth PLN 4). Accumulated points entitle you to receive a prize worth PLN 1,800 gross (450 points x PLN 4 = PLN 1,800.00) and can be used to purchase min.1 product from the entire range available in the online warehouse mediaexpert.pl.

The product indicated by the customer, will be ordered by the Organizer and sent to the Participant's address indicated in the promotional application.
